

VILLAGE OF GEORGETOWN, OHIO

ORDINANCE NO. 1090

AN ORDINANCE ESTABLISHING NEW ELECTRIC RATES  
FOR ELECTRIC CUSTOMERS OF THE VILLAGE OF GEORGETOWN, OHIO AND  
DECLARING AN EMERGENCY.

BE IT ORDAINED by the Council of the Village of Georgetown, Brown County, Ohio, two-thirds (2/3) or more of all members thereof concurring as follows:

SECTION 1. That Ordinance No. 579, known as the Codified Ordinances of the Village of Georgetown, as amended by Ordinance Nos. 728, 826, 834, 858 and 873 of the Ordinances of the Village of Georgetown be further amended to include the following revised regulations which shall be a part of Title V, Public Works, Chapter 51, Utilities, Electric:

51.12 RESIDENTIAL SERVICE: RATE RS-N

Georgetown utilities customers shall pay for all electricity consumed based on the following monthly rates and charges for residential service:

(A) NET MONTHLY WINTER RATE (Through January, February, March, April, May, October, November and December):

Energy Charge:

First 1,000 kWh	for	\$.07469/kWh
Additional kWh	at	\$.04982/kWh

Minimum bill: \$3.96

Plus or minus all kWh at Power Cost Adjustment /kWh per subsection 51.14 of the Codified Ordinances of the Village of Georgetown.

(B) NET MONTHLY SUMMER RATE (Through June, July, August and September):

Energy Charge:

All kWh	at	\$.07469/kWh
---------	----	--------------

Minimum bill: \$3.96

Plus or minus all kWh at Power Cost Adjustment /kWh per subsection 51.14 of the Codified Ordinances of the Village of Georgetown.

51.13 COMMERCIAL SERVICE: RATE GS-N

Georgetown utilities customers shall pay for all electricity consumed based on the following monthly rates and charges for commercial service:

NET MONTHLY RATE:

(A) Energy Charge:

First	6,000 kWh for	\$.08509/kWh
Next	300 kWh x kW (demand)	\$.03354/kWh
Additional kWh at		\$.02741/kWh

Minimum Charges:

Single phase:	\$ 6.06
Three phase:	\$ 12.44
Primary Metering:	\$124.34

Plus or minus all kWh at Power Cost Adjustment /kWh per subsection 51.14 of the Codified Ordinances of the Village of Georgetown.

(B) Demand Charge:


First 15 kW of Demand:	No Charge
Additional kW of Demand:	\$10.95/kW

SECTION 2. That subsection 51.10(B) of Ordinance No. 579, as last enacted by Ordinance No. 873 and subsections, 51.12 and 51.13 of Ordinance No. 579, as last enacted by Ordinance No. 873 of the Ordinances of the Village of Georgetown be and hereby are repealed as being in conflict with the provisions of this Ordinance. Except as expressly modified hereby, all provisions of Ordinance No. 728, 826, 834, 858 and 873 shall remain in full force and effect.

SECTION 3. That the rates and charges set forth in this Ordinance shall be effective with the consumption of all electricity by Georgetown Utilities Customers to be included for billing as a part of the regular utilities bill to be issued in \_\_\_\_\_, 2010.

SECTION 4. That this Ordinance is hereby declared to be an emergency ordinance necessary for the welfare of the inhabitants of the Village of Georgetown, Ohio and more particularly for the reason that it is necessary to adjust the electric rates charged to the electric customers of the Village of Georgetown in order to accommodate past and future increased costs of operation of the Georgetown Electric Department and in order that such rates may be fair and equitable and this Ordinance shall be in full force and effect immediately upon its passage.
