ORDINANCE NO. 1119

AN ORDINANCE DESIGNATING A PORTION OF WEST ALLEY STREET
IN THE VILLAGE OF GEORGETOWN AS A ONE-WAY STREET

WHEREAS, the Council of the Village of Georgetown believes that it would be in the best interest of the residents of the Village of Georgetown if that portion of West Alley Street between West Second Street and West State Street (State Route 125) was designated as one-way, northbound,

NOW THEREFORE, BE IT ORDAINED, by the Council of the Village of Georgetown, a majority or more of all members thereof concurring as follows:

SECTION 1. That West Alley Street between West Second Street and West State Street (State Route 125) shall be and hereby is designated as a one-way street, northbound.


SECTION 2. That no person shall operate a motor vehicle on West Alley Street, between West Second Street and West State Street (State Route 125), in the Village of Georgetown, Brown County, Ohio in any direction except in a northerly direction.

SECTION 3. That West Alley Street, between West Second Street and West State Street (State Route 125), in the Village of Georgetown, Brown County, Ohio Water Street, shall be marked by the street department of the Village of Georgetown with appropriate signs to indicate the lawful direction to be used by motor vehicles on said street.

SECTION 4. That any person violating Section 2 of this ordinance shall be guilty of a minor misdemeanor.

SECTION 5. That this Ordinance shall be in full force and effect from and after the earliest date allowed by law.

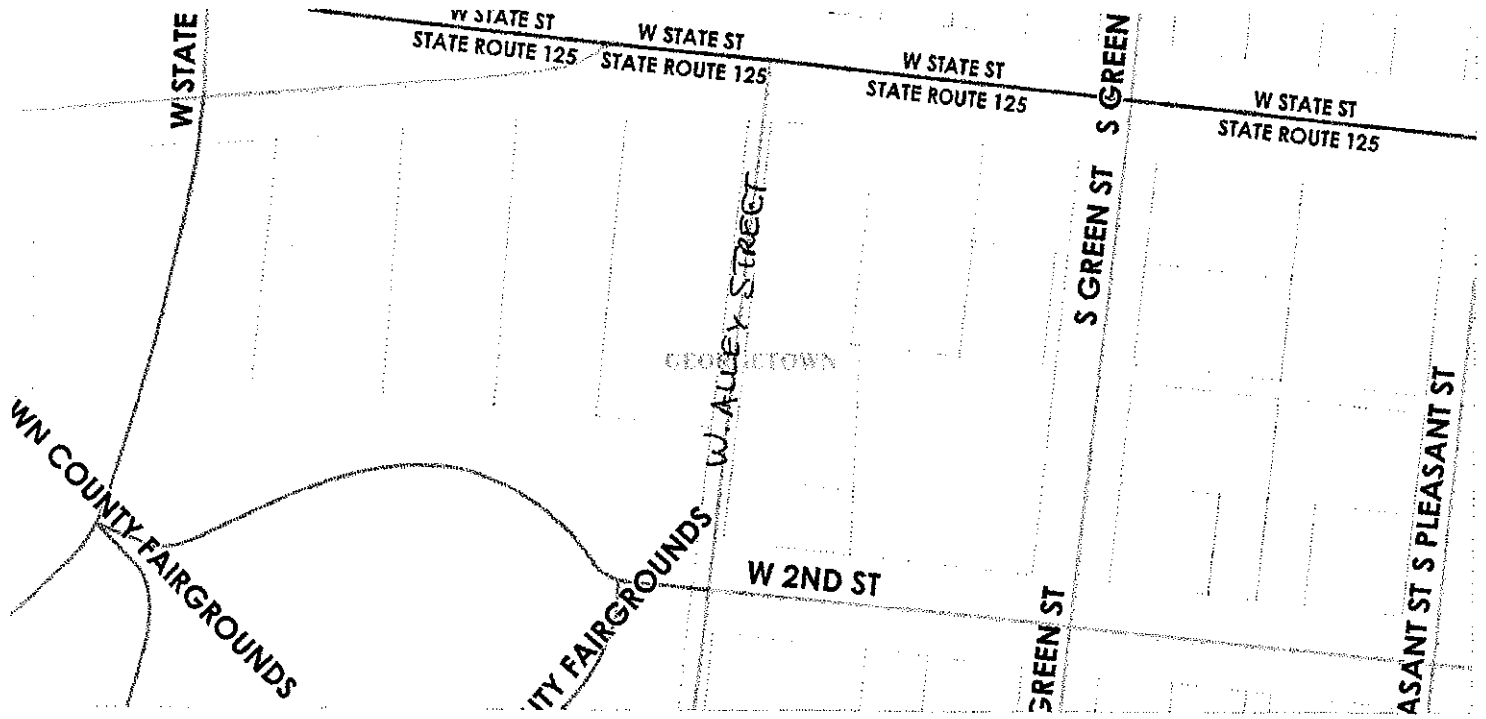

NOTICE OF PASSAGE OF ORDINANCE

Notice is hereby given that the Council of the Village of Georgetown, Brown County, Ohio did, on the 8th day of March, 2012, pass Ordinance No. 1119 entitled:

AN ORDINANCE DESIGNATING A PORTION OF WEST ALLEY STREET
IN THE VILLAGE OF GEORGETOWN AS A ONE-WAY STREET

In summary, said ordinance designates that portion of West Alley Street between West Second Street and West State Street (State Route 125) as a one-way street, northbound and provides that no person shall operate a motor vehicle on West Alley Street, between West Second Street and West State Street (State Route 125), in the Village of Georgetown, Brown County, Ohio in any direction except in a northerly direction. Said ordinance shall be effective thirty (30) days after its passage.
