

ORDINANCE NO. 1153

AN ORDINANCE AMENDING ORDINANCE NO. 1143 SECTION 3 ESTABLISHING  
EMERGENCY MEDICAL SERVICES AND CREATING FUND 2906 EMERGENCY  
MEDICAL SERVICES FOR THE VILLAGE OF GEORGETOWN,  
BROWN COUNTY, OHIO AND DECLARING THE SAME AN EMERGENCY.

WHEREAS, this ordinance is to establish the standards to protect the health, safety, and general welfare of the people of the Village of Georgetown, Ohio, the Council of the Village of Georgetown deems it necessary to provide emergency medical services by and through the establishment of a Emergency Medical Services Fund pursuant to Section 4765 of the Ohio Revised Code, Emergency Medical Services of the Ohio Revised Code.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GEORGETOWN, BROWN COUNTY, OHIO, TWO-THIRDS (2/3) OR MORE OF ALL MEMBERS THEREOF CONCURRING, THAT:

**Section 1.** The Village of Georgetown, Ohio hereby accepts and approves the establishment of an Emergency Medical Services (EMS) and also the creation of the fund of Emergency Medical Services Fund 2906.


**Section 2.** That the Council of the Village of Georgetown, Ohio hereby approves the services of the Emergency Medical Services and the Village Fire Department shall be the "operator" of these services under Section 4765 of the Ohio Revised Code.

**Section 3.** That the Village of Georgetown, Ohio shall collect and be responsible for any expenses occurred and distributed through the "EMS" Emergency Medical Service Fund 2906. That Fund 2906 will only be used for Emergency Medical Services or Capital.

Section 4. That the Mayor and the Administrator of the Village of Georgetown, Ohio are hereby authorized to execute any and all documents or other paperwork necessary to effectuate the establishment of the Emergency Medical Services to the residents of the village.

Section 5. That this Ordinance is hereby declared to be an emergency ordinance necessary for the public welfare of the inhabitants of the Village of Georgetown, Brown County, Ohio and more particularly that it is necessary of the establishment of the Emergency Medical Services and a fund number of 2906 named the Emergency Medical Services Fund (EMS) be created in order that the proper administration can be done for these services for the Village of Georgetown, Brown County, Ohio. This ordinance shall be in immediate effect upon its passage.
